**DECISION (SECHKDEY SAMRECH)**

**DECISION NO. 112 ON THE CREATION OF AN INTER-MINISTERIAL COMMISSION FOR THE  
PREPARATION AND ORGANIZATION OF IMPORT AND EXPORT PROCEDURES AND REGULATIONS**

*Phnom Penh, September 19, 1994*

- Seen the Constitution of the Kingdom of Cambodia;
- Seen the Royal Decree of His Majesty the Kingdom of Cambodia, Samdech Preach NORODOM SIHANOUK VARMAN, dated November 1, 1993 on the Formation of the Royal Government;
- Seen the Law on the Organization and Functioning of the Council of Ministers and its promulgation by Royal Decree (Kram), dated July 20, 1994; and
- Pursuant to their exigent needs

**IT IS HEREBY DECIDED**

**Article 1:**

To create an inter-ministerial commission for the preparation and organization of import and export procedures and regulations. The composition of the commission shall be as follows:

1. H.E. Kiet Chhon	Chairman
2. H.E. Ing Kiet	Member
3. H.E. Pou Sothirak	Member
4. H.E. Var Huot	Member
5. H.E. Cham Prasiddh	Member
6. H.E. Ek Sereyvuth	Member
7. H.E. Im ChhunLim	Member
8. H.E. Ith Vichit	Member
9. H.E. Chheang Yanara	Permanent Member

**Article 2:**

The roles and responsibilities of the commission shall be as follows:

1. To prepare a draft Sub-Decree on import and export procedures and regulations of the Kingdom of Cambodia and to submit them to the Cabinet of the Council of Ministers.
2. The substance of such draft shall concentrate on the followings:
  - import and export procedures and regulations of equipment, raw materials, spare parts, etc. of companies and investors to ensure the safety and timing.
  - to set up the roles and responsibilities of the customs and the relevant authorities at Sihanoukville and Phnom Penh ports and the Pochentong Airport, as well as all other border check-points.
  - to determine the deadline for submitting import and export procedures and regulations of equipment, raw materials, spare parts, etc. of companies and investors the customs and the relevant authorities at seaports, airports, as well as all other border check-points.

In the event of unreasonable and without cause delay, the individual concerned shall be fined in according to the law in force.

3. In order to ensure security and order, to set up measures to eradicate illegal check-points along national roads, and prevent harassment and extortion of vehicle owners on national roads, especially on NR No 04.
4. to set up measures to defend and maintain railways from Phnom Penh to Preah Sihanoukville in order to substitute National Road No 4 to be repaired in the future.
5. to study and prepare project for constructions of dry ports, and appoint agents in charge of collecting fees at the sea ports, airports and border check-points.

**Article 3:**

All members of this commission shall participate in meetings at the request of the Chairman.

This commission shall have the right to use the seal of the Council for the Development of Cambodia.

**Article 4:**

The Co-Ministers in charge of the Cabinet of the Council of Ministers, the Co-ministers of Interior, the Minister of Defense, the Minister of Public Works and Transports, the Minister of Economy and Finances, the Minister of Industry, Mines and Energy, the Minister of Commerce, the Council for the Development of Cambodia, and all the personalities mentioned in Article 1 shall implement this Decision from the date of its signature.
